1. Rainadevi Chhahara Rural Municipality invites electronic bids from Nepalese eligible bidders for **Purchase Supply and Delivery of Mini Power Tiller and Combine Mill** under National Competitive Bidding procedures.
2. Bidders may bid for one or several contracts, as further defined in the Bidding Document. Bidders wishing to offer discounts/cross discounts in case they are awarded more than one contract will be allowed to do so provided those discounts are included in the Letter of Bid.
3. Eligible Bidders may obtain further information and inspect the Bidding Documents at the office of Rainadevi Chhahara Rural Municipality, Chhahara Palpa or may visit PPMO website www.bolpatra.gov.np/egp.
4. Bidder who chooses to submit their bid electronically may download the bidding documents for e-submission from PPMO's Web Site www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit Rs.3,000.00 the cost of bidding document in the Project's Rajaswa (revenue) account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids. 6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 1:00PM on 05 Chaitra 2079 at the office of Rainadevi Chhahara Rural Municipality, Chhahara Palpa. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid which shall be valid for 30 days beyond the validity period of the bid.
