2. Eligible Bidders may obtain further information and inspect the Bidding Documents at the Office of the Rainadevi Chhahara Rural Municipal Executive, Chhahara Palpa.
3. A complete set of Bidding Documents may be purchased from the Office of the Rainadevi Chhahara Rural Municipal Executive, Chhahara, Palpa by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, tax clearance certificate for the fiscal year 076/77 and upon payment of a non-refundable fee of NRs.1000 till 7 phalgun 2076 during office hours.
4. Sealed bids must be submitted to the Office of the Rainadevi Chhahara Rural Municipal Executive, Chhahara, Palpa on or before 12:00 Noon, 8 phalgun, 2076. Bids received after this deadline will be rejected.
5. The bids will be opened in the presence of Bidders' representatives who choose to attend at 01:00 PM, 8 phalgun, 2076 at Office of the Rainadevi Chhahara Rural Municipal Executive, Chhahara, Palpa. Bids must be valid for a period of 45 days after bid opening and must be accompanied by a bid security issued by "A" Class Commercial Bank approved by Nepal Rastra Bank confirming to standard format as specified in the bid document amounting to a minimum of NPR 45,500, which shall be valid for 30 days beyond the validity period of the bid. If bidder wishes to submit the Cash Security, the cash should be deposited in:

and submit the original receipt of the deposited amount of cash along with the Sealed Quotation.
6. If the last date of purchasing and /or submission falls on a Government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
7. **Date of Expiry** - A minimum of 18Months from the date of delivery to final destination or for medicines with expiry date less than 18 months at least 75% of Self Life.
8. **Label** -All medicines and medical products (Strip/Bottle/Package) must contain the Label as "रैनादेवी छहरा गाउँपालिकाबाट निशुल्क वितरणको लागि" or "नेपाल सरकारबाट निशुल्क वितरणको लागि"
9. Medicine Should be supply manufacture by WHO GMP Certified Company.
10. Bottle packing medicine should be in pastic bottle.
